**Appointment of office holders and  
Committee representatives  
for coffee year 2013/14**

## Background

1. At its 111<sup>th</sup> Session, the Council will elect a Chairperson and Vice-Chairperson for coffee year 2013/14. A list of Council office holders for the previous five coffee years is provided in Annex I.
2. The Council will also consider the composition of the following Committees for the next coffee year. The current composition is shown in Annex II.
  - Projects Committee (8 exporting Members, 3 importing Members)
  - Promotion and Market Development Committee (8 exporting Members, 3 importing Members)
  - Core Group (4 exporting Members, 3 importing Members) – appointed for 2013/14 and 2014/15
  - Finance and Administration Committee (6 exporting Members, 4 importing Members)
  - Statistics Committee (8 exporting Members, 3 importing Members)
3. The Council will also appoint the Chairperson and Vice-Chairperson of the Consultative Forum for 2013/14.
4. In accordance with the terms of reference contained in document ICC-110-13, the Committees will select their Chairpersons and Vice-Chairpersons from among the designated Members at the first meeting in coffee year 2013/14. As a general rule, these offices shall alternate each coffee year between the two categories of Members. Annex III contains a list of office holders appointed for the Committees for the previous two coffee years.
