Mr Rodolfo Trampe Taubert Endorsed by the Government of Mexico

Background

- 1. In accordance with the procedures for the appointment of the Executive Director which were approved by the Council at its 118th Special Session on 23 January 2017 (see documents ICC-118-2 and ICC-118-4), the Government of Mexico has submitted the attached proposal for the appointment to the position of Executive Director of Mr Rodolfo Trampe Taubert, including his curriculum vitae and a submission from the candidate.

RODOLFO TRAMPE TAUBERT



Rodolfo Trampe Taubert was born in 1953 in Huixtla, State of Chiapas, Mexico, as part of the fifth generation of a long line of Mexican coffee growers.

Mr. Trampe holds a Bachelor's Degree in Economics and has a notable record as a entrepreneur, representing the Mexican Coffee sector both in the domestic and the international ground.

Rodolfo Trampe has been an active member of the Mexican Delegations before the International Coffee Organisation (ICO) since 2001, playing a key role in achieving support for major initiatives such as "Resolution 420" regarding coffee quality, the negotiation of the 2007 International Coffee Agreement and, later on, its consequent ratification by the Mexican Government.

Rodolfo Trampe was unanimously appointed President of the International Coffee Council for 2009/2010 period thanks to his analytical vision from a global perspective, his continued drive for honest and open dialogue between Member States, as well as his permanent interest in promoting and achieving successful agreements.

His experience in the public sector dates from 1975, when he served as advisor for the Mexican Minister of Commerce and Industrial Promotion, taking afterwards various positions in the public finance sector, primarily in the areas of credit analysis and project financing.

In 1983, he was appointed President of the Coffee Industry within the National Chamber for the Transformation Industry (CANACINTRA), position he would hold for the following ten years, acting also as representative of the Chamber before the Mexican Coffee Institute (INMECAFE). During this time, he significantly contributed to strengthen the industrial sector as a

result of the global economic trends in market deregulations and decentralisation policies.

Rodolfo Trampe is a founding member of the Mexican Coffee Council, national body that represents the industry, becoming a special advisor to its Executive President from where he played a crucial role in designing and implementing financial aid policies throughout the international coffee pricing crisis in 2001.

In 2005, he was part of the experts group that put together the current coordination mechanisms among between the different sectors in the value chain, sponsoring as well the establishment of the National Committee of the Coffee Product System, which remains the main body of all coffee-related policies.

From 2005 to 2013, Rodolfo Trampe acts as Executive Coordinator of the Mexican Coffee Association (AMECAFE), main technical advisor to the Mexican Government regarding public investment programmes. Under his leadership, AMECAFE has fostered transparency and accountability, implementing the National Coffee Census and a technological platform tool that allows the fiscal proof of all commercial operations in the Mexican coffee sector. The Association has also created a trust fund that looks after the savings of more than 300,000 producers all over the country.

Mr. Trampe has been keynote speaker in several national forums as well as in international conferences and has published numerous articles in specialised publications. In the private sector, he has founded several companies, of which he remains as part of the Board of Directors to date.

Rodolfo Trampe is fluent in English and German, apart of speaking Spanish. He is married and has three children.
