

OECD CRS database on AfT


- In the period 2006-2016
- Lists over 500 projects tagged with "coffee"
- In 60 developing countries
- Disbursements = US\$ 410 million
- Commitments= US\$ 473 million
- 0.14% of all AfT (approx. 300 billion)

Regional projects

- The database lists 59 regional projects in all regions of the world
- E.g.
- US\$ 6.8 M project by Canada in <u>Africa</u> to improve the livelihoods of small scale farmers
- US\$ 3.9 M project by Norway to develop standards and compliance capabilities in <u>Asia</u>
- US\$ 150 000 project by IDB to promote water management to ensure sustainability in coffee production (El Salvador, Honduras, Nicaragua)

Project Preparation Grants

Seed funding (up to \$50,000)


Project Grants

STDF's investment supports farmers, processors, traders and governments to meet international standards, protect health, and access global markets






Enhancing trade for coffee farmers in Papua New Guinea (STDF/PG/553)

Value: US\$1,13 M (730 K requested + 400 K form CIC)

- Food safety and quality management system for production and processing (control pests)
- National protocol for coffee production and processing (based on Codex)
- Peer group training (ToT) programme (1,500 smallholders)
- Barista training programme (local consumption, tourism)
