
- Provisions call for a review of the conversion factors for the following forms of coffee every 3 years:
 - \circ Roasted
 - o Decaffeinated
 - Liquid (such as Ready to Drink)
 - o Soluble (instant)





• Also reviewed the net weight of dried coffee solids in coffee preparations

Share of each form of coffee in exports




Survey Responses


- The online survey was launched on 25 June 2019 and the Secretariat received 14 responses
- Responses came from 12 countries covering most regions as well as net-importing and exporting countries
- The type of respondents included:
 - Members (4)
 - coffee industry associations (7)
 - private sector companies (3)

Should the Secretariat keep the factors used to calculate weight of dried coffee solids at their current levels?



Conclusion

- The majority of respondents recommend continuing to apply the conversion factors currently used by the Secretariat for the different forms of coffee.
- There was no clear consensus for alternative conversion factors that could be applied from the respondents who recommended changes.
- Responses where changes were recommended did not vary significantly from the current rates.
- The Secretariat is able to apply country-specific rates by form if notified by Members.

Update on Delta Project

Develop a commonly agreed sustainability performance measurement and reporting framework for the agricultural component of the value chain

Indicators that measure sustainability and track implementation of SDG commitments by the public and private sector across agricultural commodities

The framework does not cover the entire value chain but focuses on harmonizing reporting at the agricultural level across several commodities

This is a collaborative project between the public and the private sectors of both coffee and cotton

An expert group has researched different sustainability programs across the two commodities to find common areas as well as cross-referencing the SDGs
