# ANTECEDENTES

Formando parte de la Agenda 2030 para el Desarrollo Sostenible, conseguir una producción sostenible de café y la prosperidad de toda la cadena dependerá de que haya soluciones y recursos que permitan el logro de una productividad, calidad y eficiencia óptimas en un entorno comercial propicio y al mismo tiempo de una sostenibilidad económica, social y ambiental.

## BIOGRAPHICAL DETAILS

**Prof. Hamadi Iddi Boga**



Born 03.12.1967 in Kwale Kenya. Hamadi Boga, is currently the Principal Secretary in the State Department of Agricultural Research since March 2018.

Before that he was a Professor of Microbiology at Jomo Kenyatta University of Agriculture and Technology (JKUAT) was the Acting Vice Chancellor of Taita Taveta University since 7th October 2016.

He has a BSc in Botany and Zoology and MSc in Botany (Microbiology) from Kenyatta University in Kenya, PhD in Microbial Ecology and Microbiology from University of Konstanz, Germany and a Post-Doctoral Research stay at the Max Planck Institute for Terrestrial Microbiology in Marburg, Germany. He is also a Humboldt Fellow and was from 2010-2015 the Humboldt Ambassador Scientist for Kenya. Boga has previously, held various administrative positions in JKUAT including Chairman of Botany Department (2002-2004), Director of Institute of Biotechnology Research (2005), Dean of Faculty of Science (2007) and Principal of JKUAT Taita Taveta Campus in Voi (2007 to 2012). From 2012-2016 he was the Principal of Taita Taveta University College.

He has an extensive international and local network of scientific engagements and collaborations. He was a Board Member of the World Federation of Culture Collections ([www.wfcc.org](http://www.wfcc.org))(2010-2013). He was the Secretary of the African German Network of Excellence in Science (AGNES) (2013-2016), the Secretary (2002-2006) and later Chairman (2008-2010) of the Kenya German Scholars Association (KDSA). Boga has over 70 scientific publications in International Journals, has supervised over 15 PhD and 31 MSc students. He is an active researcher with active international collaborations.

Has a strong track record of fundraising for research. He has wide experience in Management and strategic planning.

Mr Sette is the Executive Director of the International Coffee Organization (ICO). Mr Sette has extensive experience as a consultant to trade associations specializing in international trade matters, and was Superintendent for Development of the Chamber of Commerce of the State of Rio de Janeiro (Fecomércio-RJ) and Secretary General of the Brazilian Association of Coffee Exporters (Abecafé). In the private sector, he worked for 10 years at Inter-Continental de Café S.A., a leading Brazilian coffee trading house, where he was a trader and head of the Technical Department. He also worked in the Inter-American Development Bank, in Washington, DC, USA, and began his career with the Brazilian Coffee Institute, the government agency responsible for the regulation of the coffee sector in Brazil. **Dr Andrew Karanja**



Dr Karanja has over 31 years' experience in the public sector, both locally and internationally in the fields of development economics, rural development and finance, agriculture and livestock development, and project formulation, management and evaluation. He started his career as an extension officer at the Ministry Agriculture and Livestock Development. He also worked as a Planning Officer in the same ministry. Later he joined Coffee Research Foundation (CRF) as a Research Officer/Agricultural Economist where he rose to Senior Agricultural Economist and Head of Economics Department and was part of the team that spearheaded the initial liberalization reforms in the coffee industry.

He was a research fellow at Tegemeo Policy Research Institute in 2002, where he undertook policy research on liberalization of the dairy industry, among others.

Dr Karanja joined the World Bank in 2003, as an Agricultural Economist and was later promoted to Senior Agricultural Economist in charge of the World Bank rural and agriculture portfolio in Kenya and in the East Africa region. In the recent past, he has worked as a member of the Presidential Task Force (TF) on coffee reforms and the national committee appointed to implement the Task Force recommendations. Dr Karanja has undertaken numerous consultancies and participated as a facilitator and resource person in various courses and seminars organized by consultancy firms, private and public institutions on various socio-economic issues. He has published over 26 papers and book chapters in both international and local publications. He has been given several awards and fellowships.

## **Professor Joseph Kieyah JD, PhD, EBS**



Professor Joseph Kieyah trained as a lawyer and economist with a PhD in Economics and Juris Doctorate in Law from the University of Connecticut and University of Iowa College of Law respectively. He taught at Pennsylvania State University until 2009 when he returned to his homeland to join the Kenya Institute for Public Policy Research and Analysis as Principal Policy Analyst.

In March 2016 he was appointed by the President to chair the National Task Force on Coffee Sub-Sector Reforms. Upon successful completion of the Task Force's report, the President honored him with a presidential medal namely the Elder of Burning Spear (EBS) for his outstanding work. Thereafter, the President reappointed him to his current position to oversee the implementation of the coffee reforms under the Executive Office of the President.

## **Dr Joseph Kimemia PhD, HSC, MBS**



Dr Joseph K. Kimemia is a coffee specialist who holds a PhD in Crop Science specializing in coffee agronomy. He has worked at the Coffee Research Foundation for over the 28 years (10 of which he was the CEO/Director of Research) until February 2013. He then moved to the Kenya Agricultural and Livestock Research Organisation (KALRO) headquarters as Director, Planning, Performance Management and Quality Control. He has worked as an agronomist in coffee research mainly in intercropping systems, shade in coffee, organic coffee production, introduction in new coffee areas and adaptation strategies for climate change.

He has also been involved in certification programmes in coffee. Results from his work have led to recommendations that farmers are currently using. He has published extensively and given motivational speeches to coffee farmers in the region. He is in the Technical committee of World Coffee Research (WCR). Currently he is the Chairman of the African Fine Coffee Association (AFCA) Kenya Chapter, Vice Chairman AFCA Board, acting chairman, Kenya Coffee Platform and Board Member Global Coffee Platform (Bonn Germany).

### **Ms Margaret W Mithamo**



Margaret Wanjiku Mithamo is an agricultural professional with a Bachelor of Science in Agriculture and a Master of Science in Environmental Science from Kenya Methodist University and Kenyatta University respectively. She has broad research experience with technical publications on coffee farming systems.

## Dr Nguyen Do Anh Tuan



Dr Nguyen Do Anh Tuan is the Director General of the Institute of Policy and Strategy for Agriculture and Rural Development (IPSARD) – the major think tank of the Ministry of Agriculture and Rural Development (MARD) of Vietnam in the field of policy and strategy of the agricultural sector. Dr Tuan obtained his PhD in Development Studies at the Institute of Social Sciences (The Hague, NL) in 2007, and has more than 20 years' experience in research, consultancy, and teaching in the field of agricultural policy.

He has participated in and contributed to many development strategies as well as action plans for the economy and agriculture in particular:

## Mr Macros Antonio Matos



Mr Matos has 20 years' experience in agribusiness. He was Executive-Director of the Brazilian Agribusiness Association (Abag/RP) and has also worked in the Project Management Area of Getúlio Vargas Foundation and in the Government Affairs Area of Bayer S.A.

He received a BSc degree in Agronomic Engineering and his MSc degree in Agronomy, both from the University of Sao Paulo, “Luiz de Queiroz” College of Agriculture (ESALQ/USP).

## Mr Aguinaldo José de Lima



Aguinaldo José de Lima pioneered the creation of the institutional structure – 7 coops and 8 associations – that is today behind the Cerrado Region Federation of Coffee Growers that he first presided, in Minas Gerais. He then went on to lead the Coffee Intelligence Center and to coordinate projects in a few Coffee Excellence Centers in the same state. At the federal level, Aguinaldo was an advisor to the Minister of Agriculture, Coordinator of the Sectorial Product Chambers and Secretary of the National Agricultural Policy Council.

Today, he is a director of the Brazil Soluble Coffee Association (ABICS) and a member of the national Deliberative Council for Coffee Policy (CDPC). A coffee grower for 32 years, Aguinaldo was behind the creation of the first Coffee Geographical Indication (GI) in Brazil – Café do Cerrado – and is today working to create the first Sustainable Coffee GI in the state of Rondonia.

## Dr Emmanuel Iyamuleyme Niyibigira



He is the Managing Director of the Uganda Coffee Development Authority (UCDA), a government agency responsible for promoting and overseeing the coffee industry in Uganda. He possesses a PhD in Agricultural Sciences and a MSc (with Distinction) in Crop Science from Wageningen University, The Netherlands and a MBA (with Distinction) from Uganda Martyrs University.

He has over 20 years' experience in agricultural development. He joined UCDA in October 2016, he was the National Programme Coordinator of EU-funded Agricultural Livelihoods Programmes in the Office of the Prime Minister. He also worked in the Food and Agriculture Organization (FAO), the Ministry of Agriculture, Animal Industry and Fisheries. He began his career in Coffee Research at Kawanda Research Institute.

Juan Esteban Orduz is since 2003 the President of the Colombian Coffee Federation, Inc, the subsidiary in North America of the National Federation of Coffee Growers of Colombia (FNC) - a non-profit association that represents more than 560,000 Colombian coffee growing families domestically and internationally in trade, promotion, economic development policy and government relations matters.

Mr Orduz has vast international experience in the public and private sectors, he was Minister Plenipotentiary and Deputy Chief of Mission of the Embassy of Colombia to the United States in Washington, D.C. (1998-2002), where he was one of the leaders in the design and implementation of Plan Colombia - the most ambitious US-Colombia bilateral programme for security and social and economic development. He has been Legal Vice President of Cemex, S.A. in Colombia and corporate legal counsel, as well as advisor to Mr Andrés Pastrana (President of Colombia, 1998-2002) during his presidential campaigns. Mr Orduz serves in many boards of directors in different countries, including the Global Coffee Platform-GCP (Germany and NL), Rainforest Alliance (USA and NL), the Coffee Quality Institute CQI (USA), American Friends of Fundación Cardio-Infantil 501(c) 3 (New York), co-vicechairman of the Advisory Board of the Woodrow Wilson International Center for Scholars - Latin American Program (USA, Washington D.C.) and the Universidad de los Andes Foundation (USA). Mr Orduz was a fellow at the Weatherhead Center for International Affairs at Harvard University (2002-2003), earned a law degree (J.D.) from El Rosario University in Bogotá, (1990) and a postgraduate degree in Finance at Los Andes University in Bogotá. He is fluent in Spanish (native), English and German.

Justin Archer has spent more than 20 years working in various managerial positions in the coffee industry in West and Eastern Africa. Throughout his career he has been an early sponsor of initiatives to strengthen the role of farmers in traditional agricultural supply chains. He has 10 years' experience working with governments, private companies and civil society organizations, to develop solutions for more sustainable agricultural supply chains.

## Ms Bridget Carrington



Bridget Carrington is the Managing Director of C Dorman Ltd, a major exporter and roaster in East Africa, part of the global Ecom Group, and with a turnover of 325,000 bags of East African coffee in 2018. She started her career in coffee back in 1983 working for E D and F Man, and, after 9 years in London, moved to Kenya in 1992, to gain a more rounded knowledge of the coffee value chain. Bridget played a key role in setting up the first certified supply chain of UTZ coffee in the region at Fairview Coffee Estate and Fairtrade coffee in Kenya at Gikanda FCS. As the specialty market developed, Bridget turned the focus of her company in the direction of sustainability and traceability, strengthening and championing the sale of top quality coffee from individual estates or cooperative factories from within the whole region to specialty buyers.

To achieve the goal of improving livelihoods of farmers she helped set up a company in 2006 which was tasked to develop close links with farmers through providing them with GAP's skills, financial facilities, certification and other capacity building services. This company in 2018 worked with 168,000 farmers and helped them produce 33% of Kenya Production.

Bridget is actively involved in local and regional coffee affairs via her involvement with the Kenya and Tanzania Coffee Traders Association, African Fine Coffees Association (AFCA) where she served as Kenya's Director for a two-year term and the local chapters of the International Women's Coffee Alliance (IWCA). She was Joint Chair of the Steering Committee of the the World Bank Matching Grant Fund for SME and Agribusiness Development in the Kenyan Coffee Sector where she was involved in pilot project selection and management, Coffee Standards and coffee policy review. She is currently a trustee of the Coffee Quality Institute where she is serving as Vice Chair. Bridget was the architect and founder of the Kenya National Barista Championship and later became World Barista Competition judge. Dorman's Nairobi School of Coffee was set up to train Baristas and improve coffee served in the hospitality industry. Both of these initiatives provided the foundation for better coffee awareness in the region.

## Ms Ashlee Tuttleman



Ashlee Tuttleman leads the East Africa Coffee Program for IDH – The Sustainable Trade Initiative, a Dutch organization that prototypes and drives sustainable business models for scale. IDH leads ground-breaking public-private initiatives in agriculture commodities and landscapes by de-risking innovations in order to enable increased efficiency, inclusiveness and environmental protection.

Prior to joining IDH, Ms. Tuttleman grew agribusinesses and innovations in and outside of coffee in East and West Africa since 2012. In Rwanda, she built Question Coffee (now Sustainable Growers), a specialty coffee roaster in Rwanda serving domestic demand and exports.

There she designed an innovative farmer loyalty program for 5,000 smallholders which scaled to 30,000 farmers in Rwanda and was replicated in Colombia.

Ms. Tuttleman is also a ‘human-centered design’ practitioner who applies this methodology to build product portfolios, farmer programs and drive organizational innovation. She earned her M.A. in International Affairs at The New School in New York and her B.S. in International Business at Chapman University in California.
