

Dear Ms Riechers,

Thank you for your letter dated 16 March 2021 proposing the candidacy of the International Women's Coffee Alliance (IWCA) as a representative of the Private Sector Consultative Board (PSCB) of the International Coffee Organization (ICO), as well as an extension of the Memorandum of Understanding between the ICO and the IWCA, signed on 20 September 2018.

I am pleased to confirm that the Secretariat will submit IWCA's letter of request to the International Coffee Council in its 129th Session. Please note that the Council will designate PSCB members for the two-year period starting 2021/22 in its September 2021 Session.

With regard to the extension of the Memorandum of Understanding between the ICO and the IWCA, if the proposal is agreeable to the Council, the Memorandum shall be extended for three more years, effective 20 September 2021.

We very much look forward to continuing to work with you to promote women's empowerment and inclusion as a means of achieving sustainable development in the coffee sector.
