## **Draft agenda on World Coffee Conference**

Honourable Chair & Vice Chair of the Council and all the Distinguished Members of the Organization.

The ICO during its 119<sup>th</sup> International Coffee Council meeting has awarded the responsibility of hosting 5<sup>th</sup> World Coffee Conference along with concurrent sessions of the International Coffee Council to India. The event was originally proposed to be held from 7<sup>th</sup> to 12<sup>th</sup> of September 2020 at Bengaluru, India. However due to outbreak of Covid-19 Pandemic world over, it has been postponed indefinitely.


During the 134<sup>th</sup> council meetings "We reiterated our commitment to host World Coffee Conference. Further, we requested council to prepone the event from first & second week of September 2023 to 10<sup>th</sup> to 15<sup>th</sup> July 2023 keeping in mind the calendar of events of 18<sup>th</sup> G20 Summit and the same was agreed unanimously by the Council".

As informed earlier in the council, India is the Presidency of 18<sup>th</sup> G20 countries from 1<sup>st</sup> December 2022 to 30<sup>th</sup> November 2023. During the course of hosting the event series of meetings are being conducted. It is to inform that, there has been rescheduling of some meetings and additional meetings were added in the course of time. Due to this, most of the high level dignitaries of Government of India are preoccupied with the discussions and negotiations in these important meetings up to September 2023. Participation of these high level dignitaries are very important for mobilizing greater participation of members for WCC.

In view of the above inevitable reason, we propose to reschedule the 5<sup>th</sup> World Coffee Conference & concurrent 136<sup>th</sup> meetings of the Council to 23.09.2023 to 01.10.2023. We assure the council that India will be putting all efforts to hold the WCC at the expected scale and manner.

The matter is placed for kind consideration of the Council.
