**Basis for the initial distribution of votes
among exporting and importing Members
for coffee year 2012/13**

Background

1. The Executive Director presents his compliments and wishes to remind Members that, under the provisions of paragraph (6) of Article 12 of the International Coffee Agreement 2007, the distribution of votes is determined by the Council at the beginning of each coffee year.
2. In order to permit the Council to take a decision on the distribution of votes of each category of Members group for coffee year 2012/13 it is necessary, in accordance with the provisions of paragraphs (3) and (4) of Article 12, to establish the average volume of their exports of coffee to all destinations (exporting Members) and of their imports of coffee from all sources (importing Members) in the preceding four calendar years, that is from 2008 to 2011. The attached tables have been prepared on the basis of information received from Members up to 18 September 2012 and to take into account the ratification of the ICA 2007 by Cameroon and Malawi.
3. If no objections are made by the exporting and importing Members concerned, the information contained in the attached tables will be used as the basis for the calculation of the votes of in coffee year 2012/13. It would be appreciated if Members could notify the Organization as soon as possible of any corrections to be made to these figures.
