**Exports of all forms of coffee to
exporting countries
Calendar years 2002 to 2006**

Background

1. At its meeting in September 2006 the Statistics Committee received information on exports of all forms of coffee to exporting countries from all origins to enable the Committee to analyse this trend.
2. In accordance with the Rules on Statistics contained in document EB-3830/02, exporting Members are requested to provide information on total imports by month, by form of coffee and by origin. Since September 2006, some exporting Members have responded to requests by the Organization by providing information on their imports of coffee by origin and by form.
3. The tables given in this document show data received from exporting Members on their total imports and total imports by origin each year from 2002 to 2006. It may be noted that data for 2006 may be partial as some authorities in exporting countries have to contact their customs authorities or central banks in order to obtain data on imports.
4. Table 1 shows data on imports from 2002 to 2006 as declared by the exporting Members listed. The last column in this Table gives the 5-year average of these imports in the same period. This table also shows that declared exports to exporting countries have averaged to 2.93 million bags. However, the difference between declared exports to exporting countries and declared imports by exporting countries, which have provided import data, averages some 2.36 million bags in the period.
5. It should be noted that some exporting countries, which have been reported in Monthly reports as the final destination of the coffee exported by all exporting Members, namely Cuba, India, Mexico and Thailand, have yet to provide the Organization with reports on their imports.

Action

The Statistics Committee is requested to analyse the results presented in this document and to make the appropriate recommendations for action.
