Background

1. As requested by the Statistics Committee, the Secretariat has continued to monitor exports of organic coffee based on information received from exporting Members in compliance with the Rules for the application of a system of Certificates of Origin, contained in document EB-3775/01, which came into effect on 1 October 2001. Data may be incomplete or partial for some exporting countries despite their efforts to adjust their statistical systems to comply with the Rules.

2. The tables in this document show exports of coffee labelled as "organic¹" by origin, by form in calendar year 2007 based on Certificates of Origin (volumes) and Monthly Returns – volumes and their respective percentages. The difference between the two sources indicates that some exporting Members are still to specify their organic coffee exports on the Monthly Reports as such.

3. Information extracted from the Monthly Reports shows that the value of the organic coffee exported in 2007 amounted to around US\$100 million, considerably more than the declared value of US\$16 million reported in 2006. With the unit value of organic exports averaging at just under 160 US cents per lb, it is estimated that the total value of organic coffee could earn exporting countries just under US\$330 million, if organic exports by Peru estimated at 450,000 bags in 2007 were to be included in the calculations.

4. Exporting Members have been requested to provide their Monthly Reports in the format specified in the Rules on Statistics, contained in document EB-3830/02, so that more detailed information on organic coffee exports can be made available in the future.

Action

The Statistics Committee is requested to take note of this document.

¹ In accordance with the Rules contained in document EB-3775/01, exporting Members are to take full responsibility for ensuring that the certification of organic coffee complies with the specifications set out in ISO Guide 65 – General Requirements for bodies operating products certification.
